Notes to the reader about the transcription of these minutes:

While most of the grammar, spelling, and abbreviations were kept as close as possible to what is handwritten in the original Preparative Meeting Minutes, corrections and changes have been made to improve the readability of the minutes. Curly brackets are used to surround words or parts of words that the editors could not read or decipher: { ? }, {?ene}, {Parkin?}. Curly brackets are also used to enclose editorial notes and changes made by the editors.

Parentheses are shown as they are found in the original minutes.

Blanks in the text are shown as they are found in the original minutes.

The spelling of names has been corrected wherever obvious misspellings have been found. Otherwise, the names are spelled as they appear in the minutes. Please note that sometimes several variations of the same name do occur.

Corrections and clarifications to people's names will be welcomed by the editorial staff. The goal is to make these minutes clear, accurate, and above all, useful to the reader.

Cherry Grove Monthly Meeting opened 9 – 5 – 1821 by Whitewater Quarterly Meeting composed of {Center?}, White River and Cherry Grove Preparatives – formerly a part of New Garden Monthly Meeting.

4 – 25 – 1822 – Jericho Meeting established by Cherry Grove Monthly Meeting.

Dunkirk (Sugar Grove) opened 12 1822.

Lynn established 8th month 1823 as Indulged Meeting, made Preparative 12-1826 by Cherry Grove Monthly Meeting.

In 2nd month 1824 Monthly Meeting adjourned to meet next day no reason given.

Cherry Grove Monthly Meeting discontinued by New Garden Monthly Meeting in spring of 1825 – last Monthly Meeting minutes dated 2, 12, 1825. {Center?} attached to New Garden Monthly Meeting Cherry Grove to White River, and Lynn there an indulged meeting attached to Arba Preparative all records transferred to New Garden Monthly Meeting.

The Yearly Meeting held the latter part of 10th month 1825 appointed committee to visit Quarterly Meetings and Monthly Meetings which recommended that Cherry Grove Monthly Meeting be reestablished which was done in 11th month 2nd 7th day 1825.
