Notes to the reader about the transcription of these minutes:

While most of the grammar, spelling, and abbreviations were kept as close as possible to what is handwritten in the original Preparative Meeting Minutes, corrections and changes have been made to improve the readability of the minutes. Curly brackets are used to surround words or parts of words that the editors could not read or decipher: { ? }, {?ene}, {Parkin?}. Curly brackets are also used to enclose editorial notes and changes made by the editors.

Parentheses are shown as they are found in the original minutes.

Blanks in the text are shown as they are found in the original minutes.

The spelling of names has been corrected wherever obvious misspellings have been found. Otherwise, the names are spelled as they appear in the minutes. Please note that sometimes several variations of the same name do occur.

Corrections and clarifications to people's names will be welcomed by the editorial staff. The goal is to make these minutes clear, accurate, and above all, useful to the reader.

Winchester May 27 1895

Meeting was called to order by Charles {Hiatt?}. Dr. Huddleston was appointed chairman of the meeting and a secretary appointed.

It was then proposed by the chairman that Charles Hiatt lay before the meeting the subject to be considered at our last Quarterly Meeting. We the members of the Pastoral Committee respectfully submit the following report of our work since 1st month 1896.

As to the duties named in section one of the minute regarding our appointment please see our report of 8-31-1896 concerning the selection of Rev. C.E. Hiatt as pastor for the present year. His duties have been outlined and have been performed in such a way as to lengthen the cords and strengthen the stakes of Zion.

The ratios have been made and we think the collections have been fairly good though not as promptly paid by some of our members as could be desired.

It is encouraging to note, however, by reference to former records that there is a very decided improvement in this particular.

We have freely discussed the propriety of appointing collectors but have been unable to make any definite arrangement in this respect.

The social and financial needs of the pastor have been before us and have been looked after as best we saw our ability to do so.

By the suggestion of the Preparative

Meeting and with the co-operation of our pastor, the committee procured Rev. J. T. Kittrall to conduct a series of meetings which began 12-13-1896 and closed 12-31-1896. We can truly say that while the immediate results were very gratifying and such as follow the labors of none but those fully dedicated to

the Lord's work, we believe the harvest then gathered was but the earnest of that which is still growing and will be garnered sooner or later as the result of his faithful seed sowing while among us. "Truly God is good to Israel."

One hundred thirty five dollars (\$135.00) interest from the "Moorman Bequest Fund" has been received of which the committee recommends that the following distribution be made. viz.
